Grad Nite 2012 Date: Friday, June 1, 2012

Time: 12:55 pm until 5 am (Please note that 5 am is an *approximate* time of arrival back to LJHS)

Location: Disneyland and California Adventure Park

Check In: 12 pm on Friday, June 1, 2012 – Location of bus departure to be announced (Chaperones who are riding to Disneyland need to arrive at 12 pm to help with check in and bus loading. All Seniors and Chaperones with cars – please be sure to park your car on the street, not in any of the LJHS lots.)

RULES FOR ATTENDANCE:

- Tickets are \$95 each and must be purchased *in advance*. Tickets will be considered sold once the following is complete: Payment made via PayPal (*preferred*), cash or personal check (*made payable to LJHS PTA*) and all necessary student guide & permission/medical release forms completed and turned in or mailed. All payments and forms must be received no later than March 28th.
- Bus Assignments, collection of Permission Forms and additional Ticket Sales will be on campus, near the financial office at lunchtime March 26th, 27th, & 28th.
- Only LJHS Senior 2012 graduates may attend.
- **CURRENT LJHS photo ID required for boarding the coach buses (no exceptions—get replacements if necessary please).**
- Disneyland Student Guide **MUST BE** adhered to at all times. (*See attached*)
- LJHS school dress code **MUST BE** adhered to at all times. If ANY student is inappropriately dressed anytime throughout the evening, they will be detained, parents will be contacted and **MUST** pick their child up AT DISNEYLAND.
- The use, presence or possession of alcoholic beverages or other drugs is **NOT** acceptable. Student will be detained and parents will be contacted for immediate pickup. **SMOKING OR ANY TOBACCO PRODUCT IS NOT PERMITTED AT ANY LOCATION** during Grad Nite.
- All students, purses, pillows & backpacks will be searched prior to boarding the coach buses (by school administration similar to a school function) **AND** Disneyland security will perform a search prior to entry to Disneyland. If anything is found, the student will be detained and parents notified to pick up their student at either location, LJHS or Disneyland.

LA JOLLA HIGH AND DISNEYLAND STUDENT GUIDE 2012

Rules & Regulations

1. **CURRENT LJHS SCHOOL ID** is **mandatory** to board coach buses on June 1st. **NO EXCEPTIONS** to this rule – be sure to purchase a new LJHS ID if you cannot locate yours.
2. You must arrive at Disneyland aboard a LJHS scheduled coach bus. You will not be allowed into Disneyland if you arrive by private vehicle.
3. Students will **NOT** be allowed to enter Disneyland if:
 - a. You do not have a ticket purchased through LJHS
 - b. You arrive by private car
 - c. You are not dressed according to the dress code (see below)
 - d. You are under the influence of drugs or alcohol before, during or after Disneyland
 - e. You are carrying a weapon of any kind.
 - f. You are carrying or using cigarettes or any tobacco product.
 - g. Your behavior is NOT acceptable to Disneyland personnel based on the Rules and Regulations set forth in this Guide.
4. Once past security, you will be able to park hop between Disneyland and California Adventure Park. Once the parks close to the general public for the night, you will have a private party at Disneyland Park until 3 am.
5. ALL prescription medications, including inhalers, MUST be included on your *Permission/Medical Release Form* (see attached) in order to be approved for Grad Nite and MUST be checked in with your Chaperone before departure.
6. Disneyland sets all rules of behavior & dress. If any student becomes a behavior problem or disobeys any of the rules, his/her parents will be contacted and REQUIRED to pick up their student at Disneyland. They will NOT be allowed to return on the LJHS coach buses.
7. ONLY LJHS 2012 graduates may attend Disneyland Grad Nite.
8. ABSOLUTELY NO refunds after March 28th.
9. Bus assignments will be made March 26th, 27th & 28th, **first come, first serve**. There will be NO changes of bus assignments allowed once you choose the bus you would like to ride on, so please plan ahead with your friends.
10. No food or open containers will be allowed on the bus.
11. Park on the streets only—PLEASE DO NOT USE THE POOL OR SCHOOL LOTS.

- Clothing or accessories that drag on the ground and create a potential tripping hazard
- Wedding dresses
- Sharp or pointed accessories that may cause injury
- Masks or makeup that could be construed as part of a costume
